In continuation to this office procs. in the ref.(2) cited, all the Deputy Educational Officers in the District are informed that in the ref.(3) cited, the Director of Government Examinations, A.P., Vijayawada has informed that the Spot Valuation pertaining to SSC Public Examinations March'2019 is scheduled to be conducted from 03.04.2019 to 15.04.2019. The Director of Government Examinations, A.P., Vijayawada has issued instructions to make all necessary arrangements for smooth, effective and orderly conduct of Spot Valuation.

Further it is also informed that, in the ref.(2) cited, all the Deputy Educational Officers in the District are instructed to submit the list of the teachers those who are handling X Class since two years to enable to appoint them as Assistant Examiners for peaceful and orderly conduct of Spot Valuation pertaining to SSC Public Examinations March'2019.

In view of the above all the Deputy Educational Officers in the District are once again instructed to prepare and submit the list of Assistant Examiners of their jurisdiction according to seniority duly following the instructions mentioned below.

- The Teachers who are on long Medical Leave may be exempted.
- Teachers having service 02 years for retirement may be exempted.
- Teachers having chronic diseases may be exempted.
- Pregnant women may be exempted.
- Teachers having mother feeding babies may be exempted.
- Presidents and General Secretaries of all recognized teacher unions need not be appointed for any of the examination duties, and they may be exempted.

In view of the above all the Deputy Educational Officers in the District are hereby instructed to submit the list of Assistant Examiners according to seniority on or before 12.02.2019 by 02.00PM to enable to appoint them for conduct of Spot Valuation pertaining to SSC Public Examinations March'2019.
